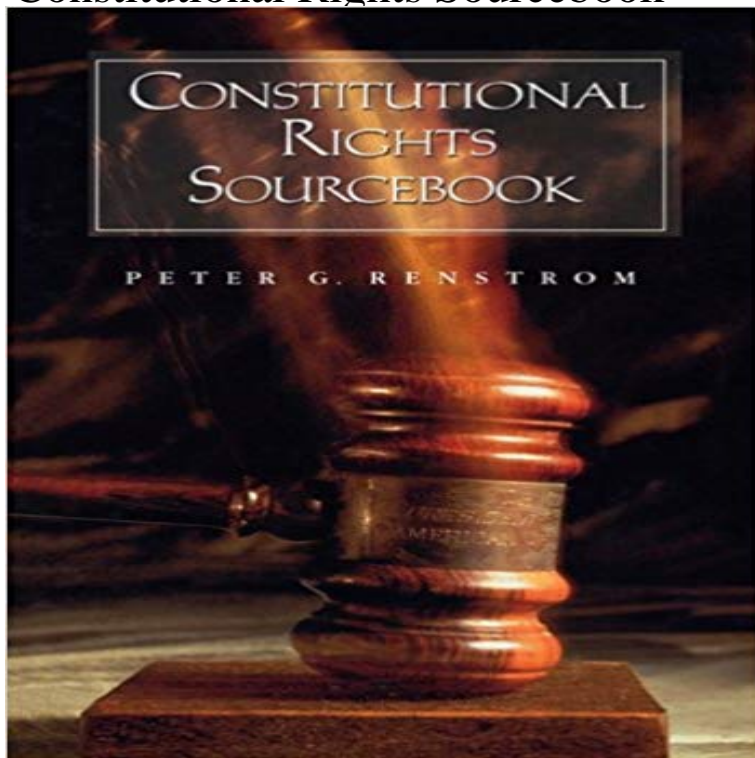


## Constitutional Rights Sourcebook
