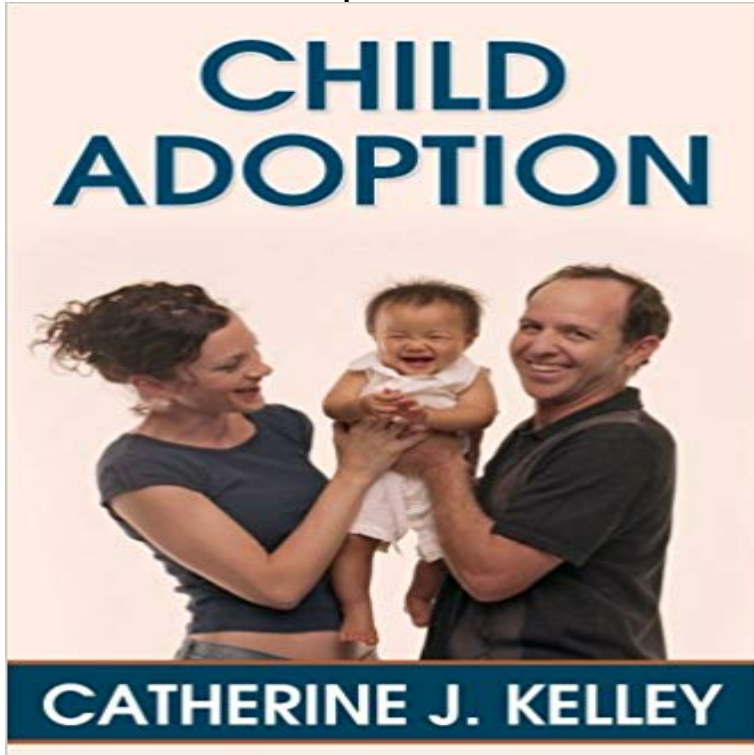


# Child Adoption: The Adoption Process, Types of Adoption And The Decision Of Adoption
