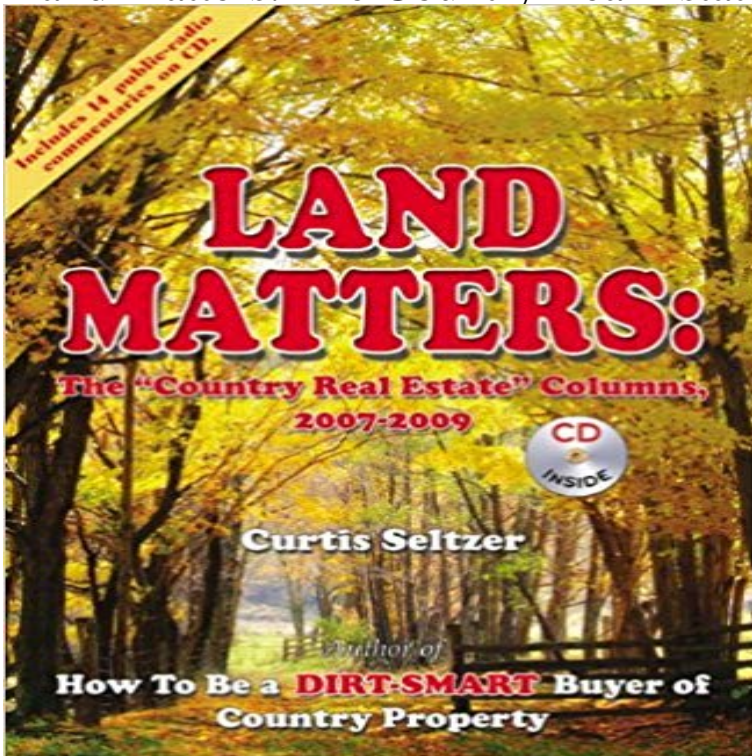


Land Matters: The Country Real Estate Columns, 2007-2009
