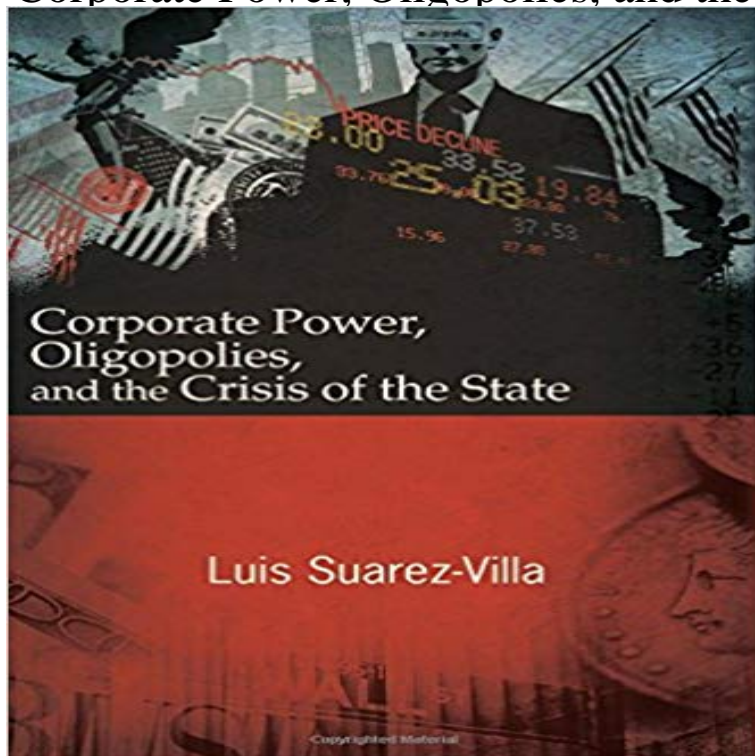


Corporate Power, Oligopolies, and the Crisis of the State
