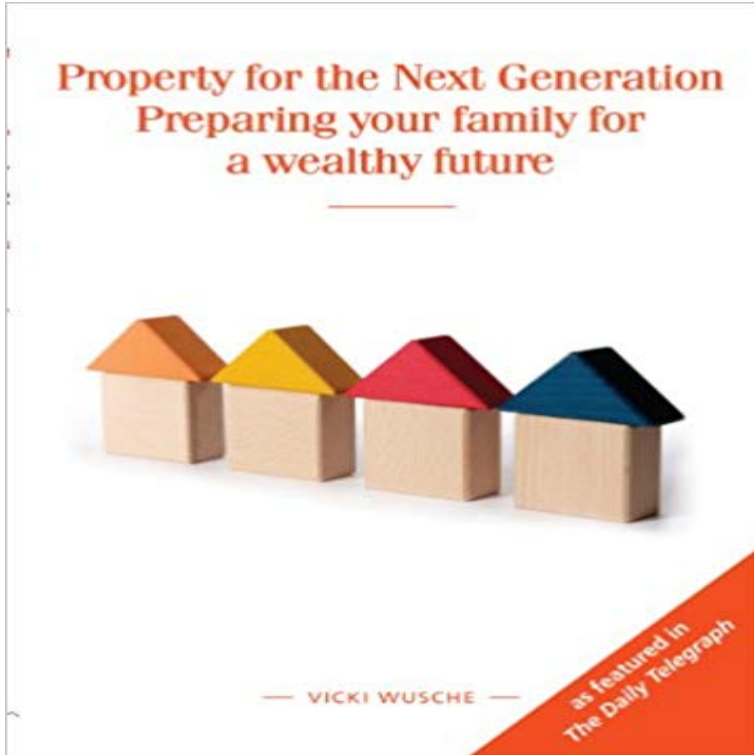


Property for the Next Generation: Preparing your family for a wealthy future
