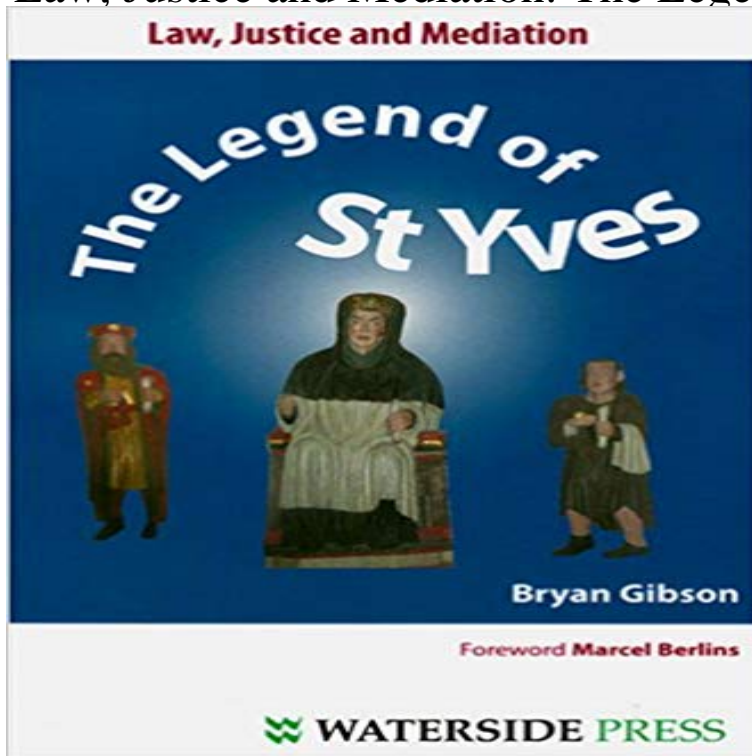


Law, Justice and Mediation: The Legend of St Yves
