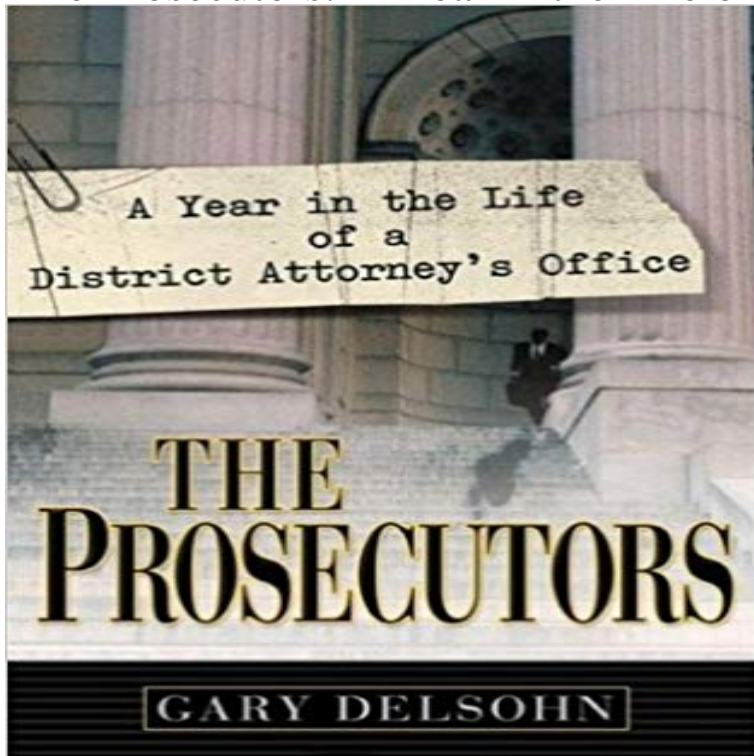


The Prosecutors: A Year in the Life of a District Attorneys Office
